## What is the Sharp County Sheriff Foundation?

The Sharp County Sheriff Foundation is a 501(c)3 nonprofit organization designed to give citizens a way to provide tax-deductible financial support beyond the scope of the Sheriff's Office's normal operating budget.

## Why Donate?

While the County budget covers basic operating expenses for the Sheriff's Office, the Sharp County Sheriff Foundation fills areas of need that may otherwise go unaddressed. Equipment wears out. Technology changes. Through donations to the Sheriff's Foundation, we may be able to address these needs more quickly and without any additional burden to taxpayers.

## How are Donations Used?

Your tax-deductible donations may be used to purchase items such as specialized equipment and technology, professional development for officers and staff, and educational scholarship opportunities for Sharp County Sheriff's Office employees and their children. Donations may also be used for the advancement and promotion of law enforcement, public service missions, and in furthering the objectives of the Sharp County Sheriff's Office and its employees.

## Who Oversees the Foundation Finances?

The Foundation is managed by a volunteer Board of Directors, comprised of local community leaders, our Chief Deputy, and our Sheriff.

### FNBC Deputy Safety Fund

The Deputy Safety Fund purchases safety equipment (tasers, bulletproof vests, weapons, spike strips) to aid in protecting our deputies.

- **Tasers:** \$1,800 each
- **Bulletproof Vests:** \$1,000 each
- **Spike Strips:** \$700 each
- **Handguns:** \$450 each
- **Patrol Rifles:** \$750 each
- **Patrol Shotguns:** \$400 each
- **Training Ammo:** \$1,000 each
- **Rat Pack for Patrol Cars:** \$3,500 each

### Life Wise Technology Fund\*

The Technology Fund provides mission-critical tools such as internet-connected laptops in each patrol car. The laptop gives each deputy a powerful safety tool to stay connected with others, including in remote areas.

- **Laptop Computers for Patrol Vehicles:** \$25,000

### Renee Clay-Circle Scholarship Fund

The Scholarship Fund provides much-needed assistance to employees and employees' children/grandchildren for advanced training including college classes. This fund is an important recruiting and retention tool for employees.

- **Employee Scholarships:** \$500/year per employee
- **Employee's Children Scholarships:** \$500/year per child
- **Employee's Grandchildren Scholarships:** \$500/year per grandchild

### Equipment & Building Fund\*

The Equipment & Building Fund donations make a lasting impact on the Sheriff's Office. Each of these items is a significant investment and improvement opportunity that is outside the operating budget of the Sheriff's Office.

- **Body Camera Computer and Software:** \$140,000
- **Body Cameras for the Jail:** \$10,000
- **Body Scanner for the Jail:** \$140,000
- **Detention Center Transport Vehicle:** \$45,000
